

Goals and Objectives

As an innovative virtual academy with a variety of electronic devices assigned to facilitate education for remote students, xxxxxxxx needs device repair coverage that will offer peace of mind, streamlined processes and reduction in man hours necessary to review and submit individual device repair invoices for payment.

What is the process to submit a covered repair?

iResQ's Asset Protection Plan repairs are submitted through our easy-to-use Asset Management Portal (AMP). Each device is tracked by serial number or asset ID through the repair process - start to finish.

What repairs are covered?

iResQ's plan covers accidental damage repairs to all device components, as well as loss from theft, fire or other natural disasters. (Police report required in event of theft.)

What is the turnaround time for a repair?

iResQ prides itself on our quality repairs and quick turnaround time. Most repairs are completed within 1-5 days from arrival at our facility.

What about shipping?

Shipping is free! Because iResQ is committed to reducing our carbon footprint (our warehouse is powered 100% by solar energy!), we prefer to batch repairs into boxes of 5 or 10, depending on customer preference.

What happens if a device is deemed beyond repair?

If a device is deemed Beyond Economical Repair (BER), we will charge a small administrative fee (\$25 for iPads, \$50 for MacBooks) to replace the item and transfer the warranty to the new device.

Is there any deductible?

No, there is no deductible and there is no limit on claims per device!


